<b>June 2, 2020</b>	<b>Budget Notice mailed to district residents (at least 6 days prior to annual meeting)</b>
<b>June 9, 2020</b>	<b>Annual Budget Vote and Board of Education Election-Absentee Ballots must be returned by June 9, 2020, 5:00 p.m. BOE Meeting 7:00 p.m.</b>
